Comments: The Parish Council would object to this planning application for the following reasons:

There is no traffic impact statement.

Originally 84 houses - now others added taking the total to over 110 houses.

9 exits onto Heckford Road within 200 yards - safety aspect.

Michael Wright Way is designed as an s shaped road - this creates a pinch point at the entrance to any retail area.

Light up retail area - negative aspect on rural landscape.

Light Pollution.

Increased use of the dangerous pedestrian crossing on Heckford's road near blind bend.

The impact of a retail area (Tesco) on the nearby playground.

Approving this planning application would result in the loss of the opportunity for land for a Doctors Surgery in the future.

The Parish Council would object to this planning application.
